Item 2- Educational Background and Business Experience

Henry S. Woloson was born in 1952. He earned a Bachelor's Degree from Wayne State University in Detroit in 1975, majoring in journalism. Henry graduated from Wayne State University Law School in 1978 and received a Masters Degree in Business Management from Central Michigan University in 1983.

Henry has been a registered investment advisor since 1990. He is the founder of Woloson Financial Management, LLC located in Clarkston, MI which he co-owns with his daughter, Laura Woloson who is also an investment advisor.

In addition to providing financial management and investing services, Henry is a practicing attorney who focuses on estate planning through his own law firm. Henry has written a book on financial management entitled "How To Grow, Employ and Transfer (GET) Wealth" which is available through Amazon. Henry also is very involved with charitable giving activities as the President of a private foundation and an advisor for several donor advised funds and charitable trusts.

Item 4- Other Business Activities

Henry S. Woloson is a registered representative ("Rep") of Harbour's Broker/Dealer, which could result in a conflict of interest. As a Rep, there may be commissions involved in certain transactions which are paid to the Rep, along with, in certain instances the Rep will also receive ongoing 12b-1 fees. These remunerations may be in the form of dealer concessions, trail fees or any other compensation generated by mutual funds, variable annuities, or the purchase or sale of securities as outlined in the respective prospectuses. Additionally, if you choose to enlist advisory services on a product that offers a dealer concession, trail fee or any other compensation, there may be a management fee charged.
